Passion, Purpose, Progress and Promise A Summary Look Back on 2021



Our 2021 story is filled with twists and turns. We needed to be incredibly nimble and pivot in real time as the pandemic and a workforce crisis tossed us about. But as we look back on the story of our year, it is with pride and thanks for - and to - the people of New Hope Community. I am happy to highlight the following key 2021 accomplishments:

- Completed the roll out of telemedicine to all 42 residential programs
- Completed a successful annual spring review for continuation of CQL Quality Assurances Accreditation
- Launched a DSP Apprenticeship Program in collaboration with the NYS DOL and SUNY Sullivan to support DSP certification opportunities (08.2021)
- Created and rolled out a hybrid "Holistic Wellness Activities Coordinator" position to holistically support individuals we serve as well as staff (09.2021)
- Hired an IT Director to grow and advance our IT capacity (new position – 09.2021)
- Hired a Senior Director of HR to advance our recruitment and retention efforts (new position 10.2021)
- Began a non-GED DSP program in partnership with Literacy Volunteers in Monticello that enables us to hire and support staff to attain their GED within their first six months of employment (10.2021)
- Received approval from Move Sullivan (a new county bus system) to provide bus service to New Hope Community to/from a campus bus stop (projected start date – spring 2022)
- Broadened our New Hope messaging to the greater community through increased press releases, radio spots, enhanced social media presence, ongoing website updates, and expanded Community Insider content
- Extended great efforts through education, onsite clinics, referral to services, etc. to close out the year with 95% of people supported being fully vaccinated and 90% of staff being fully vaccinated
- Increased leadership involvement in professional organizations (i.e., NY Alliance Government, Policy and Advocacy Council, NY Alliance Rate and Finance Committee, Sullivan 180, and Sullivan County Partnership for Economic Development)
- Created collaborative partnership projects with BOCES (i.e., summer learning experience at Hope Farm)
- Resumed as a SUNY Sullivan clinical nursing student training site
- Continued community outreach and involvement despite COVID impacts – and wrapped up the year with our 4th annual Community Outreach Dinner serving 400 hot meals to county residents
- Brought our Sensory Garden to a 99% completion point (one more musical instrument to be installed, benches and arbors to come in spring)

Welcomed four new board members: Sullivan County BOCES Superintendent, Robert Dufour; President of SUNY Sullivan, Jay Quaintance; Chief Executive Officer at Garnet Health Medical Center Catskills, Jonathan Schiller; and a retired lifelong professional in our field; Terry Grafmuller

Juliette McKerrell's term as our board chair came to a close at the end of the year. We also had our Vice Chair, Lori Stroh and another longtime board member, Annabel Lindenbaum, complete their board terms at year's end. Each board member noted has contributed to New Hope Community's journey in very valuable ways and we thank them! Effective 01.01.2022, Robert Dinerstein assumed the position of board chair. We are so grateful for a board that extends great efforts to govern and guide New Hope Community!

In other news, we committed more than \$1M in 2021 to incentives that benefited existing staff and new hires. This investment fueled our recruitment efforts, demonstrated our appreciation to our hardworking staff and bolstered retention levels. We also evaluated and increased salary points throughout the organization to remain competitive in the marketplace. Our many COVID-related costs (i.e., purchases of PPE, hazard pay, etc.) were offset with Health and Human Service (HHS) grant monies under the CARES Act. With all the costs incurred, we remained fiscally stable.

Last, but certainly not least, we now have a governor who is a much stronger advocate to our I/DD field than the immediate past administration. We also have a new OPWDD Commissioner (Kerri Neifeld) who is listening to provider agencies and demonstrating her understanding of our challenges and her commitment to partnering with us. In addition, our NYS Executive Budget is healthy and projected to remain in the black for the next 4-5 years. Our service sector is seeking changes in rate reimbursement methodology, available housing opportunities, program offerings, DSP wage increases, and much more. Whether we will enter a managed care service environment remains a question. Fortunately, we have many strong tangibles to stand on that will fuel our potential to dynamically shape a new and more positive reality moving forward.

So, there you have it. Our 2021 story continues now into 2022. Everyone has worked so hard and given so much. Our entire New Hope family has shown such love and support and I thank you. We are all in this together and I know the passion that drives our purpose still lives, efforts to fuel positive change will continue, and the promise of meaningful progress will be realized; for the people we support, for our dedicated staff, and for our greater New Hope family and community.

Resilience Reigns



In 2021 the COVID-19 pandemic continued to qualify as a challenging life event. Its impact was felt both globally and locally as it insinuated its presence throughout our lives. However, our division stayed the course, and even grew in positive ways, as we navigated ever-changing circumstances.

The fortitude, flexibility, strength, and versatility demonstrated by our Waiver Services Direct Support Professionals (DSPs

- Community Habilitation and Respite), Self-Directed DSPs (Community Habilitation, Respite and SEMP) and in-house staff was – and continues to be – amazing! And although this pandemic would never be a "wished for" experience, it has taught us things about ourselves and others that will benefit us throughout our professional and personal lives. We have been beyond resilient, and our resiliency is driving the positives that continue to be realized – despite our pandemic and workforce crisis!

Our divisional management team continued both independently and in collaboration with New Hope Community management to stay abreast of OPWDD, NYS and OSHA COVID-19 vaccination, masking, and social distancing protocols; modified agency procedures and protocols; and kept employees and families up-to-date on an ongoing basis. Staff who worked remotely in 2020 due to the pandemic resumed working on-site in 2021. Our DSPs continued to go into homes and communities to support individuals and families while maintaining appropriate COVID protocols. Supports were provided via telehealth as necessary when staff were unable to go into an individual's home. We had 27 DSPs and 6 in-house staff test COVID-19 positive in 2021 but, fortunately, all recovered and are well. The majority of our staff closed out 2021 fully vaccinated.

In 2021, Select received 98 referrals for Waiver supports and services from the various CCOs (Care Coordination Organizations). We supported 569 individuals with Community Habilitation and Respite services in 2021, which was up from 525 individuals in 2020. For much of the year, Waiver Service Managers depended on virtual platforms to attend Life Plan meetings and train DSPs. In early fall, we conducted a limited number of face-to-face meetings based on the comfort levels of individuals/families having in-person meetings.

Through June 2021, our popular Judy Voron Life Skills Studio continued to offer programs via Zoom. We offered 75 classes including Girls Group, Bingo, Games Night, Fitness and Creative Corner (Arts & Crafts) Classes and It's Complicated (a therapeutic social skills group). The instructors continued to provide innovative and fun ways for social interaction; opportunities to learn and grow; and skills to help cope with the pandemic. Enrollment continued to be high although it was evident that everyone missed in-person interactions.

During the summer months, we offered Fitness, Girls Group and Bingo outside in our "Backyard" (our rear parking lot area). In September, as COVID-19 experienced a temporary decline, we resumed in-person classes in the Life Skills Studio with limited attendance to maintain social distancing. We offered Fitness, Girls Group, Bingo, Art, It's Complicated and holiday-related group activities. We were thrilled that in just a 4-month time span, we offered 30 opportunities for individuals, to once again, gather and have meaningful social engagement – all while upholding necessary COVID-19 precautions. We were also able to hold our second annual "Trunk or Treat" Halloween Drive-Thru and December Festival of Lights Drive-Thru. Individuals in the Life Skills holiday groups made decorations that were displayed during the events. You can imagine how pleased they were to see their creations displayed as they drove through with their families and friends.

In 2021, the Self-Direction Department completed the eVero FI software implementation project. This enabled the department to grow from assisting 63 individuals at the end of 2020 to assisting 103 self-directing individuals with 105 DSPs by year's end. Our Start-Up and Support Brokers work with individuals and families to create and implement budgets using a person-centered valued outcome approach that provides flexibility and choice in decisions specific to supports, activities and staff. Utilizing eVero, our Fiscal Intermediary (FI) team reviews budgets; participants' expenses to ensure payments are within individual budget and NYS Self-Direction guidelines; and staff timesheets and evaluations. The FI list of approved classes and services has exponentially increased over time and provides a rich array of opportunities available to our self-directing individuals.

As we listen to the changes outlined by the new administration and the plans proposed by Governor Hochul and President Biden, we are optimistic that our service sector will finally receive the financial support it so desperately needs; and, that DSPs will finally be recognized for the critical role they play in the lives of individuals with developmental disabilities. I continue to be grateful to each and every member of the incredibly resilient team at Select Human Services.

Last year posed more challenges than most of us have seen in a lifetime and Select has tirelessly met them head on. We continue to maintain our longstanding reputation of being the Provider of Choice for Community Habilitation and Respite services in Westchester County (and beyond) and look forward to the continued growth of Self-Direction this coming year. We also look forward to having increased opportunities to come together with our New Hope family in 2022 as (hopefully) COVID-19 recedes into the background of our lives.

New Hope Community Appoints New Board Chair



New Hope Community is proud to announce the appointment of Robert Dinerstein as Board Chair.

Robert Dinerstein, who has been a board member since 2016, is a professor of law and founder/director of the Disability Rights Law Clinic at the American University Washington College of Law (AUWCL), where he has taught since 1983. Bob has dedicated his career to helping others in our field. In addition to teaching, he serves as co-chair of the disability rights committee of the American Bar Association's Section of Civil Rights and Social Justice and is the Section's liaison to the ABA Commission on Disability Rights, on which he was a commissioner from 2018-21. He also sits on the board of directors as President of the Equal Rights Center and is Vice Chair of the New Hope Community Foundation Board.

Bob has worked as an attorney in the U.S. Department of Justice's Civil Rights Division, Special Litigation Section, where he handled federal court cases advocating for the rights of people with intellectual disabilities. In 1994, he was appointed by President Clinton to serve on the President's Committee on People with Intellectual Disabilities until 2001. Bob brings his extensive knowledge of how to serve those with intellectual and developmental disabilities to our team. Bob's commitment to the human services field goes beyond his professional experience; his sister Andrea is a long-time member of New Hope Community.

Robert M. Dufour, Ed.D.

Jay Quaintance

Robert M. Dufour, Ed.D. serves as the District Superintendent/Chief Executive Officer of Sullivan BOCES located in Liberty, NY.

Dr. Dufour has worked in Sullivan County for the past 20 years and is committed to academic excellence and the provision of positive educational experiences for local students. His expertise in developing regional partnerships will help New Hope Community further empower the men and women we support and strengthen our community.

Before joining BOCES, he served for seven years as the Superintendent of Schools at the Eldred Central School District in NY. He is a Board Member of the Sullivan County Chamber of Commerce, and is a member of the Sullivan County Rural Health Network and the Sullivan County Opioid Task Force.

He also serves on the community advisory board for Sullivan 180, a regional partnership for healthier lifestyles, and on the Board of Directors of the Sullivan County Broadband Local Development Corporation, which strives for greater internet accessibility. Dr. Dufour resides in Pond Eddy, NY.

Jay Quaintance joined SUNY Sullivan as Interim President in August 2016, becoming President in 2017. Prior to this position, from September 2014, he served as Assistant Secretary for Education in the Office of New York State Governor Andrew M. Cuomo. His work there included Statewide P-12 and Higher Education budget, policy development, and implementation. Prior to this position, Jay served as Assistant Vice Chancellor and Assistant Provost for Community College Policy and Planning at the State University of New York. In that role he provided system support to the 30 SUNY community colleges for the implementation of the SUNY strategic plan. His portfolio included coordinating efforts to advance many of SUNY's critical efforts within the community college sector to ensure student access and success, with a focus largely on improving outcomes in the areas of college readiness, remediation reform, and workforce and workplace development.

Jay comes to his current role following nearly 20 years of higher education experience in New York and New Mexico. Prior to joining SUNY System Admin, he served as the Assistant Dean of Academic Affairs at SUNY Schenectady, where he oversaw the college's retention and enrollment management efforts. At SCCC he also served as Professor and Chair of the Department of Developmental Studies, taught developmental writing, and was Director of the federally funded TRIO Student Support Services program. Additionally, he helped launch and lead college-level curriculum development and alignment for Schenectady Smart Scholars Early College High School.

Mr. Quaintance currently serves as Chair of the Sullivan 180 Board of Directors and is a member of boards of the Sullivan Catskills Visitors Association, the Sullivan County Partnership for Economic Development, Sullivan County Chamber of Commerce, and Sullivan County Workforce Development. In the past, he served as President of the Board of Directors of Cornell Cooperative Extension of Schenectady County, the Open Stage Media Advisory Committee, and as a member of the Town of Niskayuna Planning Board and Zoning Commission.

Jonathan Schiller

Jonathan Schiller was appointed the Chief Executive Officer of Garnet Health Medical Center Catskills in 2017, providing executive leadership for the Harris and Callicoon hospital campuses, as well as health system-wide executive support for the Hospitalist, Intensivist, Psychiatry and Emergency Management services. He originally joined Garnet Health in 2004 as Administrator of Revenue Cycle Management and was later promoted to Vice President and Site Administrator of the Arden Hill Campus. In 2009 he was promoted to Vice President of Hospital Operations, in which he oversaw operations on the Arden Hill and Horton Campuses in addition to providing organizational leadership to multiple ancillary departments. After overseeing the relocation of two hospital campuses into one new hospital building in 2011, he was promoted to Chief Operating Officer in which he oversaw daily operation of Garnet Health Medical Center.

Prior to joining Garnet Health, Mr. Schiller was the Director of Patient Accounting at New York University Medical Center, and a member of Cap Gemini, Ernst and Young's national healthcare consulting practice, with specific areas of focus in hospital revenue cycle management and financial turn-around projects. He volunteers his time as a member of the Board of Directors of the American Heart Association, Sullivan County Partnership for Economic Development, Sullivan County Chamber of Commerce, and Christ Health Care Ministry.

Mr. Schiller earned a Bachelor of Science degree in Social Services from LeMoyne College and has Master of Health Systems Administration degree from Rochester Institute of Technology. He is a Fellow of the American College of Healthcare Executives and member of the Healthcare Financial Management Association.



Terry Grafmuller

Terry Grafmuller brings his passion for community, leadership experience, and networking credentials to our board. Terry began his career in January 1973 in the US Air Force, where he loaded ordinance and tested weapons systems in the F4-E fighter jets. While in the military, he spent three years located in Homestead, Florida and one year in the Philippines, when he was honorably discharged in January 1977. At that time, Terry began working for C.E. Mills Chevrolet in Callicoon.

In January 1978 Terry moved to Poughkeepsie, NY where he began his career at IBM assembling computers. He soon transitioned positions to Department Technician and then on to Department Manager. Throughout his 15-year career at IBM, Terry held various positions of leadership in the planning and engineering departments. After being downsized from IBM in June 1993, Terry and his family moved back to Sullivan County where he was self-employed in the construction industry until he joined Sullivan Arc in January 1996 as Assistant Production Manager in their sheltered workshop. Shortly thereafter, Terry was promoted to Director of Vocational Business Operations, a position he held until he retired from ARC of Greater Hudson Valley (formerly Sullivan Arc) in August 2021.

In 2010, Terry joined the Sullivan County Chamber of Commerce Foundation Board and holds the position of Secretary where his primary focus was administering the Leadership Sullivan Program. He was a member of all Arc Sullivan-Orange fundraising committees and, for the past six years, along with his wife, are Subzero Heroes taking the plunge into a frozen lake in February in support of Alzheimer's awareness and research. Terry is also a member of the Liberty Rotary Club where he currently serves as the President-elect. He volunteers his time as a pickleball and racquetball instructor at SUNY Sullivan. Mr. Grafmuller received his Associate of Applied Science degree in Business Administration from SUNY Sullivan.

New Hope Community Partnered with StationMD to Offer Enhanced Medical Care in All of Our Homes

At the end of 2020, New Hope Community became the first agency in Sullivan County to offer telehealth services provided by StationMD to more than half of our residences, streamlining health services and avoiding unnecessary exposure to COVID-19. In October of 2021, we expanded this partnership to offer telehealth services for all of our 42 homes. Now, when any In February alone, New Hope Community averaged 25 calls a month to StationMD, and over the following six months, 174 individuals had been cared for without the disruption of leaving home and being in an unfamiliar or disturbing setting. Of those cases, 157 were treated without a visit to the emergency room. The service has resolved the need for additional staffing in homes when a

of the nearly 240 people supported by New Hope Community need urgent medical care, they can receive it remotely, 24/7, from board certified physicians who specialize in treating people with I/DD.

StationMD

Funding from the Statewide Healthcare Facility Transformation Program grant made it possible for New Hope Community to join the program in November 2020, with the initial contract to connect 28 of our homes with the service, starting with those who are most at risk of chronic or serious illness. Within the first six months of implementation, the program resulted in a 90% reduction in visits to the hospital and urgent care facilities for ailments such as rashes, pink eye, minor infections or nausea. It is projected that the program will save an estimated \$30,000 annually in expenses, including additional staff salaries resulting from transportation and emergency room visits. staff member accompanies an individual on their trip to the hospital, urgent care or physician's office.

Telehealth has revolutionized our clinical services. Easy-to-use medical

"stations" enable our nurses and staff to electronically connect with StationMD's board certified physicians using tablets. High-tech stethoscopes operate on Bluetooth technology to transmit lung and bowel sounds in real-time for patient evaluations.

A trip to the doctor's office or to the emergency room can be traumatic for anyone but especially for people who may have sensory, communication or mobility issues, and require medical transport with support staff to accompany them. Streamlining care with new technology often creates a better patient experience and achieves significant cost savings as well.

Never has there been a more important time to recognize and honor our nurses. As we paused to celebrate Nurses Week, we thanked our nurses for their unwavering care and dedication. Their selfless work will forever be appreciated. They have persevered with true grit and strength and we thank them for their contributions, compassion and commitment to helping others.

In honor of National Nurses Week, our nurses were recognized for the critical role they play in improving, championing and promoting the health of the people we support and our staff. The celebration began on Thursday, May 6, with a relaxing activity – painting bird houses! The following Monday, everyone enjoyed a catered breakfast of bagels and coffee and the week ended on Wednesday with a Mexican-style dinner catered by the Community Café. Assemblywoman Aileen Gunther, who is a nurse herself, made a special appearance and shared in the recognition of our nurses. Each nurse received a gift bag that included novelty nursing socks, baseball cap and lotion.

The roar of motorcycles approaching marked the arrival of over a dozen energetic volunteers at Hope Farm, located on the grounds of SUNY Sullivan. Ready to help with the annual fall harvest, on September 19, bikers from the Knights Order Law Enforcement Motorcycle Club (LEMC), a group made up of law enforcement, first responders, military/veterans, civilians, and the Knights of Columbus from the Church of Saint Peter in Monticello, assisted with the busy harvesting season.

After a quick tour of the farm, led by Megan Greene, Head Farmer, everyone spent their afternoon picking vegetables. Working alongside Megan, three of our Farm Associates Anthony, Tara and Dean, and the volunteers unearthed 211 lbs. of farm-fresh potatoes and picked 70 lbs. of peppers.

Each year, more than 11,000 pounds of fresh organic vegetables are grown on the farm and are used in New Hope Community's residential homes, by the college's culinary arts students in meal preparation, and are donated to community nutrition programs and food pantries to combat food insecurity.

The volunteer event was coordinated by David Lee, a retired Monroe, NY, detective and member of the Knight's Order, Orange County Chapter, who planned the event in honor of his son David Joshua, a resident of New Hope Community. "Helping out at the farm is a really good cause and I am proud that the Knights Order can honor my son with this day of service. We have a great group of people in the club and are always looking for a way to give back to people in the community," he said. The Sullivan County Chapter of the Knights Order joined in right away once they learned of this local event.

Fostering Creativity and Connections with OUISI

In 2014, while working in the finance industry, Paul Brillinger sat at his desk and thought, "Is this really what I want to be doing?" He soon left his corporate job and began his path creating a game that matched his love for photography and making connections. Fast forward to 2021, his business' growth is matched by the mass of orders being placed for OuiSi ("we-see"). OuiSi is a set of 210 visually-connecting photo cards, with activities and games that foster creativity and ignite curiosity, regardless of age. Through trials and tribulations, Paul and his business partner, Kaz Brecher, have found their unique space in the game industry that provides meaningful connections through mindful moments of play.

What started off as an app for your phone in 2015, OuiSi transformed into a physical game ready for purchase in January 2020, right before the COVID-19 pandemic. "I would walk around New York City with three boxes of my game ready to sell and waltz into museums, art galleries - any place that had a retail space - and shared my love of photography," says Paul, "I wanted OuiSi to be available in places where like-minded people could find it." It didn't take long for OuiSi to require an e-commerce website where it is currently being sold.

OuiSi was brought to New Hope Community through CEO Debbie McGinness. In 2020, when Paul and his partner Katie moved in near Debbie and her husband Bill's home, they quickly became friendly neighbors. Paul graciously shared his game with Debbie and explained that its purpose was to connect people. Debbie says, "After playing the game myself, I knew this would be an excellent addition to our homes and programs at New Hope. We always want our folks to express themselves through creative projects. " Soon afterwards, every one of our 42 homes, including our art and music programs, had OuiSi with an open invitation to play.

OuiSi contains beautifully unique photo cards that share similar patterns, shapes and colors. Most photos were even taken by Paul himself, along with contributions from Kaz and a few friends. You then work through the game, matching cards, when you think, "This reminds me of that!" Here's the catch - everyone will see something different in the cards.



There's no right or wrong answer, no time limit, just unlimited possibilities to follow your intuition. The people at New Hope have used OuiSi to be creative, find like patterns, and interpret the cards in their own unique ways.

"What's become more important to us now, more than ever, is taking a breath and meditating on our surroundings, but not everyone likes to practice traditional meditation," says Paul. "OuiSi offers a different type of quiet moment where you look at the card and are invited to notice all the intricacies you typically would have passed over." At New Hope Community, OuiSi allows the people we support to decide what they notice in the photos and express themselves through this in-the-moment experience. OuiSi reminds us that, although everyone may see the world uniquely and differently, each individual's perspective is just as valuable as our own.






